# Thursday, September 12, 2019

## 9:30am – Hiawatha National Forest Tour

Meet at the Rapid River/Manistique Ranger District office 8181 U.S. Highway 2, Rapid River MI 49878 (Rapid River is approximately 125 miles west of St. Ignace).

The objective of the field trip is for participants to see the result of different site prep and planting methods on the West Unit of the Hiawatha NF (Central Upper Peninsula of Michigan). Management in this non-core area uses a different approach than the Huron-Manistee NF. A retired Forest Service Silviculturalist will present a background on the evolution of the site prep and planting methods on the West Zone of the Hiawatha NF. The field trip is designed to be beneficial to the KWCT Breeding Range Subcommittees: Expanding Breeding Range Workgroup and Improving Habitat Management Workgroup, but is also open to others.
